Special Board of Education Meeting

- BOE resolution adopting Budget (at least 24 days prior to budget vote on 05/15/12)
- BOE resolution adopting Property Tax Report Card (transmit to SED next business day)

04/15/12*

Candidates must file 1st of 3 statements of campaign expenses & contributions (2nd statement due 05/10/12; 3rd statement due 06/04/12 [EDN 1529(a, b, c)] NOTE: 1st stmt is due before candidate petition filing deadline!

Closing date for submission of petitions for propositions to be placed on ballot (not later than 30 days preceding election at which the question or proposition is to be voted on)

04/17/12

First publication of Legal Notice of voter registration for school elections [must publish 1x in each of 2 weeks preceding registration day on 05/01/12] (also publish 04/24/12)

04/23/12*

Deadline to submit Property Tax Report Card submission to SED is 24 days before budget vote

04/24/12

Budget document must be completed seven days before public hearing on 05/01/12 (EDN §1716.2) Budget statement & attachments should be available to the public upon request at least seven days before the budget hearing, but in any event not less than 14 days before the vote

04/25/12 School Board candidate nominating petitions due to District Clerk by 5:00 PM [twenty days before election on **05/15/12**] (EDN §2608.1)

05/01/12 Voter Registration at **District Office** from **Noon to 4:00 PM** for residents not registered with **County Board of Elections** (last day of registration shall not be less than two weeks preceding election & must include at least 4 hours between 7:00 AM and 8:00 PM [EDN §2606.2])

Budget Hearing and Candidates Night at 6:30 PM @ JHS Lecture Hall (budget hearing must be at least 7 but not more than 14 days before budget vote)

05/02/12 First publication of Legal Notice of filing of updated voter registration lists [must publish 1x in each of 2 weeks preceding election on **05/15/12**] (also publish **05/08/12**)

05/08/12 Last day for absentee ballot applications to be submitted by voters who choose to receive absentee ballot by mail [EDN §2018-a(2a)]; last day to mail absentee ballots out

05/09/12 Deadline for mailing Budget Notice (after hearing, but no later than 6 days prior to budget vote)

05/14/12 Last day for absentee ballot applications to be submitted by voters who choose to pick up ballot from District Clerk [EDN §2018-a(2a)]; last day to hand out absentee ballots

05/15/12 **BUDGET VOTE & BOARD ELECTION** (3rd Tuesday in May; statewide, except Big 5 districts)
Polls open 11 a.m.- 8 p.m. (nine consecutive hours in small city school districts, two after 6p.m.)
Absentee ballots due to District Clerk by 5:00 PM [EDN §2018-a8]
Vote Results will be announced in the JHS auditorium lobby at approximately 8:30 PM

You may vote if you:

- °Are at least 18 years old and
- °Are a US Citizen and
- °Have been a resident of the Greater Johnstown School District for the past 30 days and
- °Are a Registered Voter
